

Ang Pau Giveaway Campaign (“Campaign”)

Introduction

1. The Campaign will commence from 11 January 2023 and ends on 5 February 2023 (“**Campaign Period**”). SOCAR Mobility Malaysia Sdn. Bhd. (“**SOCAR**”, “**we**” or “**us**”) reserve the right to amend or extend the duration of the Campaign at any time as we deem fit without prior notice and/or liability to the SOCAR members.
2. This Campaign is governed by the terms and conditions set out hereunder (“**Terms and Conditions**”). By accessing our services during the Campaign Period, you agree to be bound by these Terms and Conditions, and shall be deemed to have given your consent for the collection of personal information and the use of such personal information shall be in accordance with SOCAR’s privacy policy which can be accessed at <https://socar.my/terms> with no monetary payment.
3. Information on how to participate in this Campaign forms part of these conditions of entry. Registration for and/or participation in this Campaign is deemed as acceptance of these conditions of entry. Acceptance of these Terms and Conditions is a condition of entry.

Campaign Mechanics

1. In conjunction with the Lunar New Year celebration, we are rewarding our SOCAR members with red packets (“**ang pau**”) during the Campaign Period subject to the following terms: -
 - (a) This Campaign is open to all existing SOCAR members who have made bookings of the SOCAR vehicles within the territories of Johor Bahru, Kota Kinabalu, Penang, Melaka and Ipoh during the Campaign Period (“**Eligible Areas**”);
 - (b) These ang pous will then be placed in randomly selected SOCAR vehicles within the Eligible Areas and one unique promotional code (“**Promotional Code**”) will be stuck on top of the ang pau and shall be given at random. The details of this promotional codes that the SOCAR members may receive are as follows:-
 - (i) **Promotional Code for RM38 off your SOCAR vehicle booking**
 - One (1) redemption only per promotional code received by SOCAR Member;
 - This promotional code is only applicable for bookings of the SOCAR vehicles with a minimum of five (5) hours per booking;
 - This promotional code is only made available in the Eligible Areas; and
 - This promotional code shall only be valid for all bookings of the SOCAR vehicles made during the Redemption Period (as defined in Item 1(c) below) with the exception of Toyota Vellfire.

(ii) **Promotional Code for RM88 off your SOCAR vehicle booking**

- One (1) redemption only per promotional code received by SOCAR Member;
- This promotional code is only applicable for bookings of the SOCAR vehicles with a minimum of eight (8) hours per booking;
- This promotional code is only made available in the Eligible Areas; and
- This promotional code shall only be valid for all bookings of the SOCAR vehicles made during the Redemption Period (as defined in Item 1(c) below) with the exception of Perodua Axia, Perodua Bezza, Perodua Myvi, Kia Picanto, Nissan Almera, Honda City, Honda Jazz, Proton Iriz, Mazda 2, Toyota Vios, Toyota Yaris and Volkswagen Polo.

(iii) **Promotional Code for RM188 off your SOCAR vehicle booking**

- One (1) redemption only per promotional code received by SOCAR Member;
- This promotional code is only applicable for bookings of the SOCAR vehicles with a minimum of twelve (12) hours per booking;
- This promotional code is only made available in the Eligible Areas; and
- This promotional code shall only be valid for all bookings of the SOCAR vehicles made during the Redemption Period (as defined in Item 1(c) below) with the exception of Perodua Axia, Perodua Bezza, Perodua Myvi, Kia Picanto, Nissan Almera, Honda City, Honda Jazz, Proton Iriz, Mazda 2, Toyota Vios, Toyota Yaris and Volkswagen Polo.

(c) Where the SOCAR member is a lucky recipient of this ang pau, the SOCAR member may keep the ang pau as a souvenir and key in the promotional code for their usage between following periods:-

- (i) 11 January 2023 to 19 January 2023; and
- (ii) 30 January 2023 to 12 February 2023.

(The periods stated within c(i) and c(ii) above shall be collectively referred to as the “**Redemption Period**”)

General terms and conditions:-

SOCAR reserves the right, at its discretion, to cancel, terminate, suspend, change, modify, add, or remove the Campaign (or any part thereof) without prior notice and/or without assigning any reason thereto at any time. For the avoidance of doubt, any cancellation, termination or suspension by SOCAR shall not entitle you to any claim or compensation against SOCAR for any and/or all losses or damages suffered or incurred as a direct or indirect result of the act of cancellation, termination or suspension.
